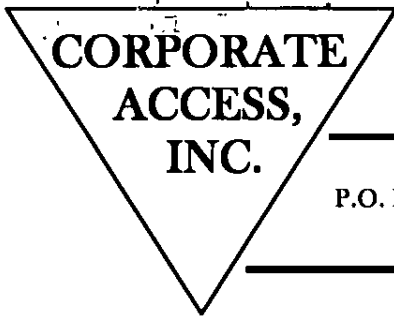

Bylaws


