ARTICLES OF INCORPORATION For Brian Anthony Matano Motorsports, Inc.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Brian Anthony Marano Motorsports, Inc. Principal place of business is 4 Royal Way #602, Boca Raton, Florida 33432.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
