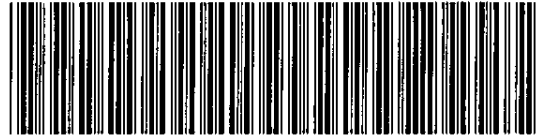

ARTICLE I - NAME

The existence of this corporation shall commence with the filing of these articles. The term of existence of this corporation is perpetual.

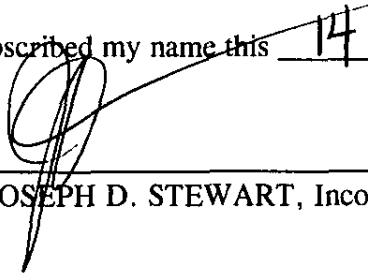

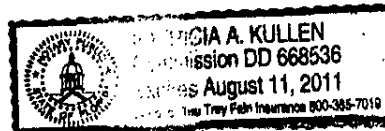
