ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of the professional association under the Professional Service Corporation Act pursuant to Chapter 621 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I.
NAME AND PRINCIPAL OFFICE
