**ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

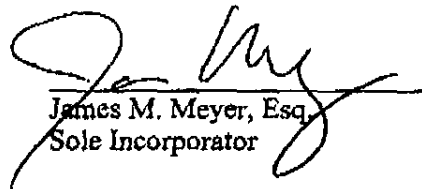
ARTICLE VIII. BYLAWS

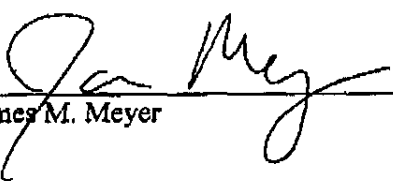
