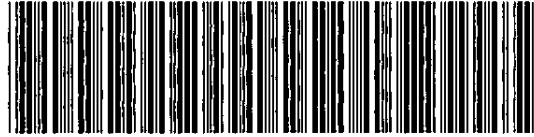

The undersigned, acting as incorporator of this corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is ALMA INGRAM FLOWERS, INC.

ARTICLE II. DURATION

This corporation shall exist perpetually commencing on the date of filing these Articles.
