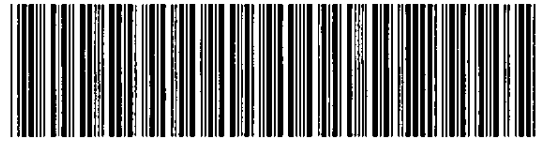

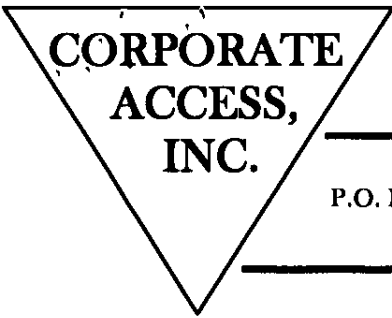


ARTICLE IX. AMENDMENT


