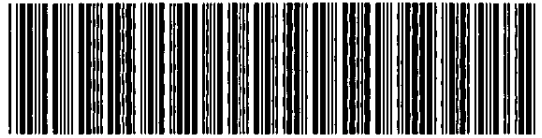

ARTICLE VII ~ PRE-EMPTIVE RIGHTS:


