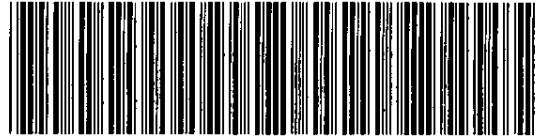

In Compliance with Chapter 607 and/or Chapter 621 of the Florida Statutes:

### Article I: Name

The name of this corporation is Spartan Engineering and Services, Inc.

### Article II: Principal Office

The purpose for which the corporation is organized is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of the State of Florida other than the banking business, the trust company business or the practice of a profession required special licensing by the State of Florida that the officers of this company do not have. One of the base services of this company will be providing engineering consulting services in the field of Civil-Sanitary Engineering.
