ARTICLES OF INCORPORATION OF 2M & D PROPERTIES, INC.

The undersigned hereby subscribes to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

Ī.

The name of the corporation is 2M & D PROPERTIES, INC.

IJ.

This corporation is organized for the purpose of purchasing, selling, leasing, or otherwise acquiring, holding, refurbishing, improving, renovating, managing, developing, mortgaging, or otherwise encumbering, renting, and disposing of real and personal property of every description whatsoever both within and without the state of Florida, and for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under Florida Statutes, Chapter 607.
