ARTICLES OF INCORPORATION
OF

AMERICAN PROFESSIONAL INSPECTORS, INC.

The undersigned incorporator, being a natural person over the age of (18) years hereby make, subscribe, acknowledge, execute and file with the Department of State these ARTICLES OF INCORPORATION for the purpose of forming a Corporation for profit In accordance with the laws of the State of Florida.

Article 1...Name

The name of the Corporation is... AMERICAN PROFESSIONAL INSPECTORS, INC.

Article 11.....Principal Office.

The principal office and mailing address is 8230 N.E. 8TH PLACE, MIAMI, Florida 33138, but this Corporation shall have the power to move the principal office to any other address in the State of Florida and to establish branch offices at such other places within or without the State of Florida that may be deemed expedient.

Article 111...Perpetual Existence

The Corporation shall have perpetual existence unless sooner dissolved by law.

Article IV...Nature of Business

The general nature of the business to be transacted by the Corporation will be to engage in any activity or business permitted under the laws of the United States and of this State.

Article V...Capital Stock.

The maximum number of shares of Capital Stock authorized to be issued by this Corporation shall be (500) shares of common stock with a par value of \$1.00 per share. Each of the said shares of stock shall entitle the holder to one vote at any meeting of the stock holders. All or any part of the said Capital stock may be paid for in cash, in property (other than stock or securities), or in labor or services at a fair valuation to be fixed by the incorporator. All stock when issued shall be fully paid.

Article VI...Initial Capital.

The amount of capital with which this Corporation shall begin business shall be no less than Five Hundred Dollars (\$500.00).

Article VII. . Board of Directors.

The shareholders of this Corporation shall act in lieu of a Board of Directors, and all the powers, privileges, duties and responsibilities that otherwise would apply to the directors of the company shall instead apply to, be exercised by and be attached to the shareholders of the company. In voting of any matter, the shareholders shall be entitled to one vote for each share of stock owned: and in all matters a majority of the company's issued stock shall constitute a quorum, and a majority of shares at any meeting where a quorum is present shall decide any question before the meeting.
