# ARTICLES OF INCORPORATION OF TAMPA KING OF TIRES, INC.

The undersigned subscriber, a natural person competent to contract, acting as incorporator of a corporation (hereinafter referred to as the "Corporation") under the provisions of the Statutes of the State of Florida, adopts the following Articles of Incorporation:

## ARTICLE I

#### NAME

1.1 Name. The name of the corporation is Tampa King of Tires, Inc.

#### ARTICLE II

#### PRINCIPAL OFFICE

- (c) To operate a retail/wholesale tire store to include the sale of any/all automotive related items.
- (d) To do everything necessary, proper, advisable or convenient for the accomplishment of the purposes hereinabove set forth, and to do all other things incidental thereto or connected therewith, which are not forbidden by the Statutes of the State of Florida, by other law, or be these Articles of Incorporation.
- (e) To carry out the purposes hereinabove set forth in any state, territory, district or possession of the United States or in any foreign country, to the extent that such purposes are not forbidden by the law of such state, territory, district or possession of the United States or by such foreign country.
- (f) To enter into, make, perform, and carry out, or cancel and resoind, contracts for any lawful purposed pertaining to its business.

#### SHARES

4.1 Number of Authorized Share. The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares of common Stock, having a par value of One Dollar per share.
