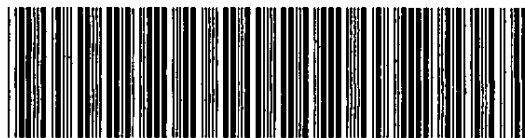



## ARTICLES OF AMENDMENT



2. The foregoing amendments were adopted by the Stockholders and Directors of the corporation on the 10<sup>th</sup> day of July, 2008.


