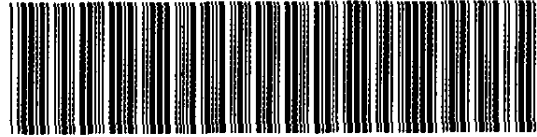

1. Article I of said Articles of Incorporation presently reads:

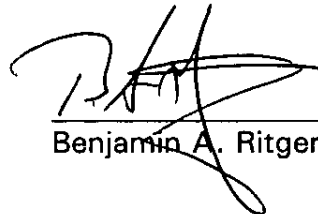
"The name of this corporation is and shall be
