**ARTICLES OF INCORPORATION  
OF

*The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I - NAME**

The name of the Corporation is: **Americana Roofing Corporation, Inc.**

**ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE**
