

Article XIII – Amendment



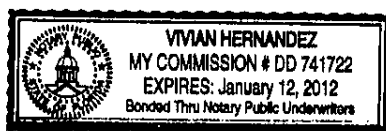


