ARTICLES OF INCORPORATION OF XILYNKS CORP.

The undersigned, acting as incorporator of Xilynks Corp. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Xilynks Corp.
