

The undersigned, acting as incorporator of this corporation pursuant to chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation.

Article ONE.

NAME OF CORPORATION


