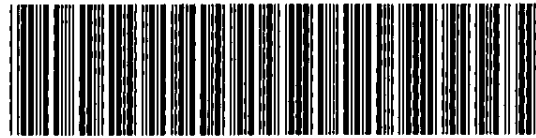

**ARTICLES OF INCORPORATION  
OF  
JSM CONTRACTORS, INC.**

The Undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

**ARTICLE I - NAME**

The name of the corporation is **JSM CONTRACTORS, INC.**

**ARTICLE II - PRINCIPAL OFFICE**

The physical street address in Florida for the principal office of the corporation is 354 Highland Street, Mount Dora, Florida 32757. The mailing address of the corporation is 354 Highland Street, Mount Dora, Florida 32757.

**ARTICLE III - SHARES**

Number. The aggregate number of shares that the corporation shall have the authority to issue is 1000 shares of Capital Stock, all of which shall be common shares without par value.




