ARTICLES OF INCORPORATION

OF

The undersigned incorporators, being natural persons over the ages of (18) years hereby make, subscribe, acknowledge, execute and file with the Department of State these ARTICLES OF INCORPORATION for the purpose of forming a Corporation for profit in accordance with the laws of the State of Florida.

Article 1...Name

Article 11....Principal Office.
