ARTICLES OF INCORPORATION

OF

R. W. STEIN & CO., INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1 NAME AND ADDRESS

- Section 1.1 Name. The name of the corporation is R. W. STEIN & CO., INC.
- Address of Principal Office. The address of the principal office of the Section 1.2 corporation is 135 West Bay Street, Suite 400, Jacksonville, Fl. 32202.
- Mailing Address. The mailing address of the corporation is 135 West Bay Section 1.3 Street, Suite 400, Jacksonville, FL 32202.

ARTICLE 2 DURATION

Duration. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, except that if they are not filed by the Department of State of Florida within five business days after they are executed, corporate existence shall commence upon filing by the Department of State.

ARTICLE 3 **PURPOSES**

Purposes. This corporation is organized for the purposes of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.

ARTICLE 4 CAPITAL.

Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 10,000 shares of voting common stock having a par value of \$0.01 per share.

Bylaws may be amended or repealed from time to time by either the board of directors or the shareholders, but the board of directors shall not after, amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the board of directors.
