Pursuant to the provisions of Section 607.1006, Florida Statutes, Accu-Cut Service, Inc., a Florida corporation, document number P08000043287 that filed its Articles of Incorporation with the Florida Department of State on April 29, 2008, hereby adopts the following amendment to its Articles of Incorporation:

FIRST: The Corporation's Articles of Incorporation are hereby amended by deleting Article I in its entirety and inserting a new Article I to read as follows:

ARTICLE I

The name of the corporation is Accu-Cut, Inc. (the "Corporation").

SECOND: These Articles of Amendment were approved by Written Consent in Lieu of Special Meetings of the Sole Director and Sole Shareholder of the Corporation dated as of October 1, 2010. The number of votes cast for the amendment by the shareholder was sufficient for approval.
