

ARTICLE I. NAME

The name of this corporation shall be JUPITER ISLAND CONCIERGE SERVICES, INC.

ARTICLE II. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III. NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business.


ARTICLE X. PREEMPTIVE RIGHTS

at the price at which it is offered to others. This preemptive right is limited to the extent that no fractional shares will be issued or sold.


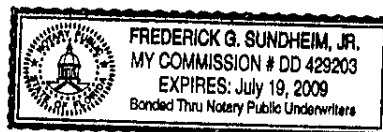
