ARTICLES OF INCORPORATION OF HAPPY HORSE FARRIER SERVICE, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

Name of the corporation is HAPPY HORSE FARRIER SERVICE, INC.

ARTICLE II Duration

The period of duration of the corporation is perpetual.

ARTICLE III Purpose

The purpose or purposes for which the corporation is organized are to engage in any activities or business permitted under the laws of the State of Florida.
