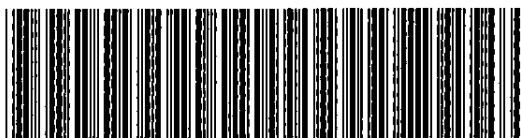

ARTICLE I

NAME:
