ARTICLE I -- NAME

The name of this professional corporation, formed under the provisions of Chapter 621, Florida Statutes, is Jonathan Sanders, M.D., P.A.

ARTICLE II -- PRINCIPAL OFFICE

The aggregate number of shares which this professional corporation shall have authority to issue is One Thousand shares of common stock, each of which is to have a \$0.10 par value.

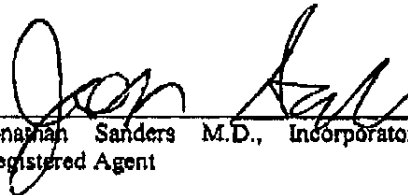
ARTICLE X -- INDEMNIFICATION
