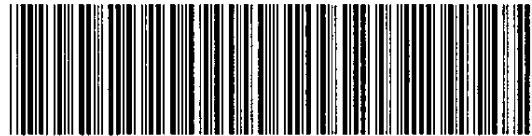

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
SPA 360 INC

Article F of the Articles of Amendment to the Articles of Incorporation of SPA 360 INC, a Florida corporation (the "Corporation") filed with the Florida Department of State on April 6, 2009 contained incorrect information that did not accurately reflect the ownership of the Corporation. In order to correct the information set forth in the Articles of Amendment filed with the Florida Department of State on April 6, 2009 and to otherwise amend its Articles of Incorporation, as amended, in its entirety, the Corporation hereby adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I.
NAME

The name of this corporation is SPA 360 INC.

ARTICLE II.
PRINCIPAL OFFICE

The principal office of this corporation and the mailing address of this corporation is 3230 West Kennedy Boulevard, Tampa, Florida 33609.

ARTICLE III.
DURATION

This corporation shall exist perpetually.

ARTICLE IV.

The Bylaws shall be adopted by the Board of Directors. The power to alter, amend, or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.

These Amended and Restated Articles of Incorporation have been adopted by unanimous written action of the sole shareholder and sole Member of the Board of Directors of the Corporation which vote is sufficient to approve these Amended and Restated Articles of

Incorporation pursuant to Sections 607.1003 and 607.1006, Florida Statutes by Written Action dated August 12, 2009.


