Florida Statutes. The corporation is to have perpetual existence.

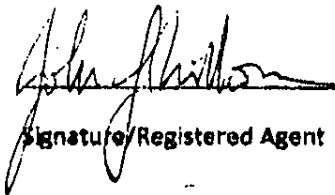
