The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **M-Tec Air, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in Gulf County, the principal place of business and street address of this corporation shall be: **228 B Cessna Drive - Port St. Joe, Florida 32456**

ARTICLE III - PURPOSE

The purpose of the corporation and the general nature of the business to be transacted shall be in construction and any other lawful business. 


