



ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF TEAM INTERNATIONAL SERVICES, INC.

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Team International Services, Inc. are hereby amended as follows:

First: Section A(1) of Article IV of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

(1) Common Stock. The aggregate number of shares of common stock (referred to in these Articles of Incorporation as "Common Stock") which the Corporation shall have the authority to issue is 50,000,000 with a par value of \$.01 per share.

Second: The foregoing amendment was adopted by the holders of in excess of a majority of the outstanding shares of Common Stock, being the sole voting group entitled to vote on the amendment, on October 25, 2020 and the number of votes cast for the amendment was sufficient for approval by the holders of Common Stock.
