ARTICLES OF INCORPORATION 2008 MAY -6 AM 10: 55

The undersigned, acting as the Incorporator of JROSTETTER, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the *Florida Statutes*, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME

The name of the Corporation is JROSTETTER, INC.

ARTICLE II - PRINCIPAL OFFICE

The street address of the initial principal office of the Corporation shall be 478 E. Altamonte Drive, Suite 108, PMB 143, Altamonte Springs, FL 32701.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, *Florida Statutes*.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock that the Corporation is authorized to issue and have outstanding at any one time is One Thousand (1,000) shares of common stock having a par value of One Cent (\$0.01) per share.

ARTICLE V - INITIAL BOARD OF DIRECTORS

A. The Corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time in accordance with the Bylaws, but shall never be fewer than one.
