

ARTICLES OF INCORPORATION

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is MH & MG PROPERTIES, INC., and its principal office or mailing address is 604 55Th. Avenue, St. Pete Beach, Florida 33706.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE 8: PREPMPTIVE RIGHTS

Each holder of the common stack of this Corporation shall have the first right (subject to adjustments to avoid the issuance of fractional pharm) to purchase shares of any other socurities that this Corporation may issue from time to time, whether or not such shares are presently anthonized, including shares from the treasury of this Corporation, in the ratio that the number of shares of common stock hold by such shareholder at the time of issue then beam to the total number of shares of common stock then outstanding. The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.

ARTICLE 11: AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
