ARTICLES OF INCORPORATION

ARTICLE I NAME

The purpose for which the corporation is organized is:

FOR the providing of residential and commercial landscape and lawn-care related services and transacting in and all lawful business, including but not limited to:

- (a) To acquire by purchase or lease lands and interest in lands, and to hold, improve, develop and manage any real estate so acquired, and to erect, cause to be erected, on any lands owned, held or occupied by the corporation, buildings or other structures, and to manage operate, lease, rent, alter or improve any buildings or other structures now and hereafter on any lands so owned, held or occupied by the corporation.
- (b) To acquire by purchase, lease, manufacture, or otherwise, any personal property deemed necessary or useful in the equipment, furnishing or improvement, management of any property, real or personal, at any time owned, held or occupied by the corporation, and to invest, trade or deal in personal property deemed beneficial to the corporation and to lease, rent, encumber or dispose of any personal property at any time owned or held by the corporation.
- (c) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes or other evidences of indebtedness and to execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as required.
- (d) To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- (e) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the capital stock, or any bonds, securities, or other evidences of indebtedness created by another corporation of the State of Florida or any other state or government and while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- (f) To enter into, make, perform and carry out contracts and agreements of every kind, for the lawful purpose, without limit as to amount, with any person, firm, association or corporation; and to transact any further and other business necessarily connected with the purposes of this corporation or calculated to facilitate the same.
- (g) To carry on any or all of its operations and businesses and to promote its objects within the State of Florida or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all of the general powers of the like corporation.

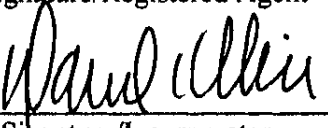
