**ARTICLES OF INCORPORATION OF
Blevins Land Surveying, Inc.**

ARTICLE I – NAME

The name of the corporation is Blevins Land Surveying, Inc.

ARTICLE II – DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III – PURPOSES

This corporation is organized for the purposes of transacting any and all lawful business.

ARTICLE IV – CAPITAL STOCK

This corporation is authorized to issue sixty (60) shares at \$1.00 par value, common stock which shall be designated "Common Shares". Sixty (60) shares shall be issued initially.

ARTICLE V – VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the issued Common Shares.

ARTICLE VI – PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which is offered to others.

ARTICLE VIII – INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) directors initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never be less than one. Special meetings of shareholders may be called by the Board of Directors of this Corporation.

ARTICLE XIII – SHAREHOLDER QUORUM AND VOTING

Fifty-One percent (51%) of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of shareholders. If a quorum is present, the affirmative vote of fifty-one percent (51%) of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

ARTICLE XIV – INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XV – AMENDMENT

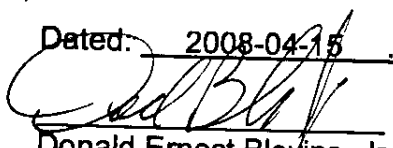
