The undersigned, acting as incorporator of a Florida corporation under the Florida Business FLORIDA Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

# ARTICLE I

The name of the Corporation is TOTS OF CLEARWATER, INC.

If the Act is amended to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director of the Corporation shall be eliminated or limited to the fullest extent permitted by the Act as so amended.
