**ARTICLES OF CORRECTION
OF THE ARTICLES OF INCORPORATION OF
ABRENA PLUMBING AND TILE, INC.**

A. The Articles of Incorporation of Abrena Plumbing and Tile, Inc. (the "Company") were filed with the Secretary of State of Florida on May 8, 2008.

B. Due to a scrivener's error: (i) the zip codes in Articles II, V and paragraph 2. of the Certificate of Designation were incorrectly represented as "32225" when, in fact, the zip codes in Articles II, V and paragraph 2. of the Certificate of Designation should be "32202" and (ii) the language portion of the description of the authorized shares was incorrectly represented as "one hundred" and instead the language portion of the description of authorized shares should be "one thousand."

C. After correction, the Articles of Incorporation shall read as follows:

**"ARTICLES OF INCORPORATION
OF
ABRENA PLUMBING AND TILE, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of this Corporation is Abrena Plumbing and Tile, Inc.

ARTICLE II-PRINCIPAL OFFICE

The street address of the initial principal place of business and mailing address of this Corporation are 225 Water Street, Suite 1800, Jacksonville, Florida 32202.

ARTICLE III-NATURE OF BUSINESS

The purpose for which this Corporation is organized is to provide plumbing services and conduct any and all lawful business.

ARTICLE VIII-BYLAWS

The Board of Directors shall adopt Bylaws for this Corporation and from time to time may modify, alter, amend or rescind the same by majority vote of the members of the Board of Directors present at any regular or special meeting or by written consent of all of the members of the Board of Directors.

ARTICLE IX-AMENDMENTS

This Corporation may amend, alter or repeal any provision of these Articles of Incorporation in the manner now or hereinafter provided by Florida law.
