ARTICLES OF INCORPORATION OF REVERE SUPPLY INTERNATIONAL CO., INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I <u>Name</u>

The name of this corporation shall be REVERE SUPPLY INTERNATIONAL CO., INC.

Article II Principal Office and Mailing Address

The principal office and mailing address of this corporation shall be 5323 Highway Avenue, Jacksonville, Florida 32254.

Article III Capital Stock

- Section 3.1. Capital Stock. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time 200 shares of common stock having a par value of \$25.00 per share. The corporation shall only have one class of stock.
- Section 3.2. Restriction on Transfer of Stock. The shareholders may, by bylaw provision, by shareholders' agreement recorded in the minute book or by endorsement on each stock certificate, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.
- Section 3.3. Approval of Shareholders Required for Merger. The approval of the shareholders holding sixty percent (60%) or more of the capital stock of this corporation eligible to vote with respect to any plan of merger or consolidation shall be required in every case, whether or not such approval is required by law.
