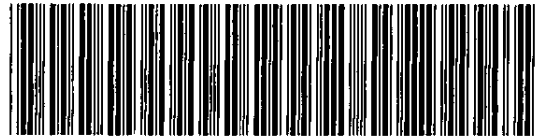

ARTICLE I



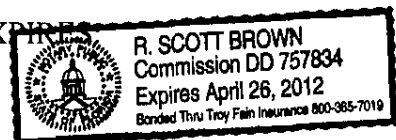
