THE UNDERSIGNED, for the purposes of forming a Corporation, under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE ONE

The name of the Corporation is:

The duration of the Corporation is perpetual.

The general purposes for which the Corporation is organized are the following:

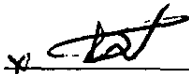
ARTICLE NINE
