ARTICLES OF INCORPORATION

OF

MONCRIEF EXPRESS, INC.

The undersigned Incorporator of these Articles of Incorporation is a natural person competent to contract and hereby forms a corporation for profit under the General Corporation Act and other laws of the State of Florida.

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is Moncrief Express, Inc. and its principal office is located at 2203 Dunn Avenue, Jacksonville, Florida 32218, with a mailing address at P.O. Box 11325, Express Jacksonville, FL 32239.

ARTICLE II. DURATION AND EFFECTIVE DATE
