ARTICLES OF INCORPORATION
of
CONTRACT MATERIALS PROCESSING, INC.

ARTICLE I

The name of the Florida business corporation being formed hereunder pursuant to Fla. Stat. 607 is:

CONTRACT MATERIALS PROCESSING, INC.

ARTICLE II

The principal place of business of the corporation is at the following street address: 9243 Via Classico East, West Palm Beach, Palm Beach County, Florida 33411. The mailing address for the corporation is P.O. Box 212230, West Palm Beach, Florida 33421.

ARTICLE III

The corporation is authorized to engage in the business of providing consulting and technical services relating to plant and process design for the chemical and petroleum industries, brokerage of materials and toll manufacturing services for those industries, and all other business activities and transactions permitted by law and not required to be stated in the articles of incorporation.

ARTICLE IV

The corporation is authorized to issue 25,000 shares of its capital stock to its shareholders, each share having a par value of \$1.00.

ARTICLE V

The corporation shall have only one director when the corporation has only a single shareholder; the corporation shall have two directors if and when the corporation has two shareholders; and the corporation shall have three directors if and when the corporation has three or more shareholders. 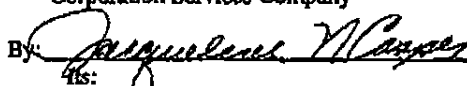
