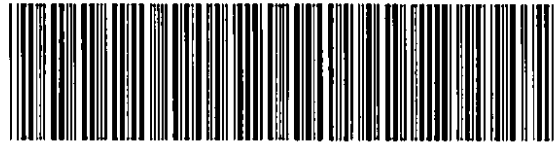

The Articles of Incorporation of the Corporation are hereby amended with effect from 3.31.20:

ARTICLE V - AUTHORIZED SHARES

Article V (a) is amended so that the Corporation shall have the authority to issue up to 4,000,000 (Four Million) Common Shares having a par value of \$1.00 per share AND 2,000,000 (Two Million) Redeemable Preferred Shares having a par value of \$1.00 per share AND 1,000,000 (One Million) Non-Voting Common 'B' Shares, ranking Pari Passu with the Common Shares. Each of the Common Shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders, and for the avoidance of doubt, such voting rights are not conferred on any holder of Non-Voting Common 'B' shares.

Apart from the above amendment, all other clauses remain the same.


