

**ARTICLES OF INCORPORATION
OF**

ALBRECHTA LAW FIRM, A Professional Association

The undersigned acting as incorporator of a professional service corporation for profit under the Florida Law, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of the Corporation is ALBRECHTA LAW FIRM, A Professional Association The principal place of business is 15824 Hampton Village Drive, Tampa, FL 33618; the mailing address shall be: 15824 Hampton Village Drive, Tampa, FL 33618.

ARTICLE II. DURATION

This Corporation shall have perpetual existence, commencing upon filing of these Articles.

ARTICLE III. PURPOSE

This corporation is organized under Chapter 621, Florida Statutes (2007) for the sole and specific purpose of rendering professional legal services and related legal services, and shall have as its shareholders only other professional corporations, professional limited liability companies, or individuals who themselves are duly licensed to render professional legal services in the State of Florida.

ARTICLE IV. STOCK

The Corporation is not authorized to issue shares in series.

ARTICLE V. PRE-EMPTIVE RIGHTS

There shall be no pre-emptive rights.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is: 15824 Hampton Village Drive, Tampa, FL 33618, and the name of the initial registered agent of this Corporation at that address is: MARK J. ALBRECHTA . This address is the same as the mailing address of the corporation.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

This Corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the BY-LAWS, but shall never be less than one (1).




