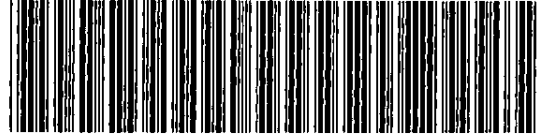

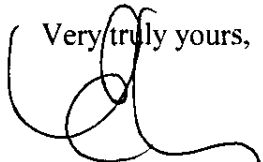

ARTICLE I

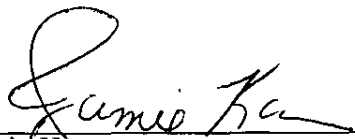

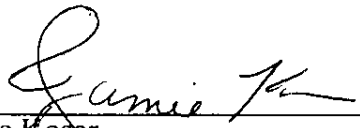

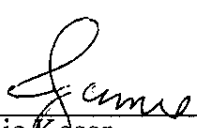
