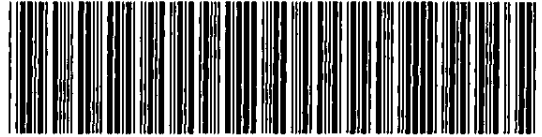

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **CONCO PROPERTY SERVICES, INC.** and its principal place of business shall be located at **1448 NW 158 LANE, PEMBROKE PINES, FLORIDA 33028.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK




