Article I

Name. The name of this Corporation is **McDavid Welshans Consulting, Inc.**

Article II

Principal Office. The mailing and physical address of the principal office of the Corporation is:

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

Purpose.
