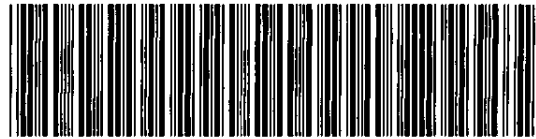

NAME

The name of this corporation is FAK Management, Inc.

ARTICLE II.

PRINCIPAL OFFICE

INDEMNIFICATION OF DIRECTORS AND OFFICERS




