ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is Brooke's Auto Motors, Inc., at 3111 Skyway Circle, Unit 107, Melbourne, FL 32934 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
