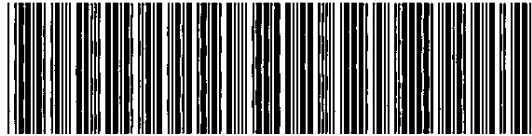



ARTICLES OF INCORPORATION

I, the undersigned, as a proper person acting as an incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

First

The name of the corporation will be Japanese Auto Specialist, Inc.

Second

The period of its duration is in perpetuity.

Third

The purpose of the corporation is to conduct business providing vehicle repair services.

Fourth

The aggregate number of authorized shares is: 1,000 shares Class "A" common voting stock.

Fifth

The corporation will not commence business until at least 100.00 dollars has been received by it as consideration for the issuance of shares.

Sixth

Cumulative voting shares of stock 1,000 authorized.


