ARTICLES OF INCORPORATION OF KARLO KROQUETA, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of KARLO KROQUETA, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is KARLO KROQUETA, INC. (the "Corporation").
